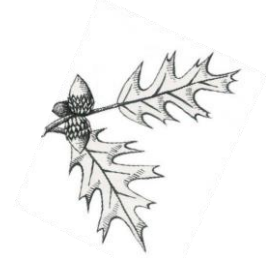

Alcohol

Club members and guests are prohibited from bringing alcoholic beverages onto Course premises.

Attire

Appropriate casual clothing and soft spikes are required. Tank tops, cut-offs, sweatpants or bathing suits are not permitted for Clubhouse or Golf Course.

Children

Parents are responsible for the conduct of their children and their guests while they are on Club property. It is the financial responsibility of the member or non-member for any charges made or damages caused by that child or the child's guest.

Golf Carts

Golf Carts are not allowed at Driving Range area. All Players must stay on Cart path. You must have a valid drivers license or 16 years and older to operate a golf cart. No more than two people are allowed in a golf cart.
